PARTICIPATION RULES, TERMS AND CONDITIONS

The Kitcars Base 2CV et Dérivés (KBD) club organises meetings for car and discovery enthusiasts. During this event, participants will have to cover a number of stages on roads open to traffic. Under no circumstances does speed come into play and no classification based on it or on an average or any other performance criteria will be made.

ADMITTED VEHICLES AND CREWS

The organiser reserves the right to accept or refuse cars that do not correspond to the spirit of this event.

Cars accepted

All cars approved to drive on the road registered in France or abroad with required documents, insurance and complying with the Rules of the Road, but exclusively in the form of :

<u>Kitcar or artisanal car with body Coupé / Cabriolet</u> / Sedan type / made imperatively on a Citroën 2CV base or derivative.

Crew

Two people, at least one of whom has a driving license.

Vehicles must comply in all respects with the Rules of the Road.

Participants must ensure the general good condition of their car.

Each crew undertakes to show good humor and mutual aid towards the other participants.

ROAD COURSE

If the road course is suggested, in NO CASE will an average speed or an imposed time be requested. The participants are motorists like any others subject to the Rules of the Road and its obligations. Each stage is made up of a starting point and an arrival point and each crew is free to adapt its route according to its interests or weather conditions, for example.

ACCOMMODATION AND CATERING

Accommodation and catering are the responsibility of the participants. In particular, they must book their accommodation individually, specifying their membership of the KBD group.

Detailed information and contacts will be given when registrations are closed.

REGISTRATIONS

On the closing date of entries, a waiting list will be opened in the event of withdrawal. Conversely, in the event that the number of entrants is insufficient, the Kitcars Base 2CV et Dérivés (KBD) club reserves the right to cancel the event. In this case, participants will be notified but cannot be reimbursed or compensated in any way whatsoever for the costs they may have incurred.

In the event of a change of date, registrations will automatically be postponed to the new date.

INSURANCE

The Kitcars Base 2CV et Dérivés (KBD) club organises with the **TRANSPYRÉNÉENNE KBD** a leisure event aimed at bringing together owners of vintage or exceptional vehicles, without any notion of speed or competition.

The Kitcars Base 2CV et Dérivés (KBD) club benefits from insurance liability cover for the organization of such events, but this cannot cover the liability of the owners vis-à-vis third parties.

The owners of the vehicles involved are personally responsible for car liability insurance vis-à-vis third parties. Vehicles circulating on the road must comply with the Rules of the Road and in particular be provided with a registration certificate, a technical inspection certificate (if required) in force and a valid insurance certificate. The participants renounce to engage the responsibility of the Kitcars Base 2CV et Dérivés (KBD) club in any capacity whatsoever. The contract concluded between the participants and the organiser is governed by French law. Any dispute it may give rise to will be subject to the exclusive jurisdiction of the Court of Nice.

The Kitcars Base 2CV et Dérivés (KBD) club does not require a driver's racing license or sporting approval for the vehicle.

EXPLOITATION / IMAGE RIGHTS

By taking part in the TRANSPYRÉNÉENNE KBD, participants authorize the Kitcars Base 2CV et Dérivés (KBD) club or any other partner or sponsor of the event to use, reproduce and distribute free of charge the name, voice and/or image of the driver or co-driver, as well as his performance, results and the image of his car, for any public relations, promotional or advertising action. This provision is valid worldwide, on all media, for an unlimited period.

PERSONAL DATA

In accordance with the French Data Protection Act loi Informatique et libertés n°78-17du 6 janvier 1978,, each crew can exercise a right of access or rectification by writing to the Kitcars Base 2CV et Dérivés (KBD) club. Finally, it should be noted that the contact details of the participants may be transmitted to the official partners of the event.

FORCE MAJEURE

The Kitcars Base 2CV et Dérivés (KBD) club will not be held responsible for delays or impediments relating to the execution of this contract in the event of the occurrence of any event beyond its control which prevents or delays the achievement of the object of the contract. as defined as **TRANSPYR1N1ENNE KBD**, contractually assimilated to force majeure. This will be the case for the following events and without this list being exhaustive:

• war (declared or undeclared), civil war, riots or revolution,

acts of piracy,

- sabotage, requisition, confiscation, embargo or expropriation,
- natural cataclysm such as violent storm, cyclone, earthquakes, flood, destruction by lightning,
- epidemics,
 - boycott, strike and lockout in any form whatsoever, work to rule, occupation of premises,
 - $\ensuremath{\,\bullet\)}$ acts of authority, whether lawful or unlawful, arbitrary or not,

• or any other event beyond the control of the Kitcars **Base 2CV et Dérivés (KBD) club.**

DISPUTE / APPLICABLE LAW & ATTRIBUTION OF JURISDICTION

This contract is subject to French law even if the service is provided for a participant established outside of French territory. In the event that a dispute relating to the contract arises between the parties, express jurisdiction is attributed solely to the Court of Nice, notwithstanding in the event of multiple defendants or warranty claims. This clause of attribution of competence will apply even in the event of summary procedure or interim proceedings.
